REMINDERS

- ~ If you are at the point where your house needs a makeover, please do not forget to contact Demerie at Grand Teton
 Property Management first. Whether you are going to repaint or stain your house a different color, add a deck, build an addition, or make some other change to your home, the Teton Springs DRC must first approve your plans.
- ~Please be advised that according to the governing documents for Teton Springs, any rental for less than 30 days is considered "short term" and is not allowed. Remember that only the Cabins and Palisades Condo Owners are permitted to rent their properties for less than 30 days. Any other homeowner will be in violation of the covenants and subject to fines and legal actions.
- ~ As your summer guests arrive, please remember that RV's and boats **may not** be parked in your driveway or on any street within Teton Springs.
- ~Please remember to keep your dog under control at all times when out and about in Teton Springs. This includes keeping your furry friend off the golf course. As a courtesy, please be sure to clean up after your pet.
- ~ If you are fishing the ponds within Teton Springs, keep in mind they are catch and release only. Be sure to use barbless hooks and only cast your line from the edge of the pond. Flies or artificial lures are permitted; bait, eggs and chumming are not. Fish on!

SHORT TERM RENTING

Homeowners, many of you are aware of the short–term rental policy in Teton Springs. For those of you who have questions, please be advised that according to the governing documents for Teton Springs, any rental for less than 30 days is considered "short term". Please remember that **only** the Cabins, Teton Springs Lodge and Palisades Condo Owners are permitted to rent their properties for less than 30 days. Any other homeowner will be in violation of the covenants and subject to fines. Please contact Grand Teton Property Management if you have any questions about this rule, as it is strictly enforced.
